## NATIONAL CHAMPIONSHIP NITE HUNT AWARDS

**Overall Winner:** \$5,000 (includes breed winner purse), original oil portrait of the winning coonhound, and a twelve (12) month supply of feed. Total potential prize package valued at \$7,160.

**Final Cast Non-Winners:** \$1,000, and a six (6) month supply of feed. Total potential prize package for each dog valued at \$1,252.

**Breed Winners (6):** \$2,000, and a six (6) month supply of feed. Total potential prize package valued at \$2,252.

Total potential Awards Package valued at \$24,428.

**Note:** Verification through a feeding affidavit form required of all winners. Otherwise, the cash award for that dog will be cut in half. Recipients of awards are solely responsible for any and all federal, state and local taxes.

### Pro Club Member Eligibility Requirements

The owner or household member on record, (in case of a dual ownership), one of the two owners must appear on the UKC Registration Certificate and be an active Pro Club Member. An active Pro Club member is a member who adheres to the Pro Club membership conditions and willingly and freely signs an affidavit stating the winning hound was fed a Purina brand food during the time frame of the competition.

Owners of all eligible dogs to receive invitation and entry form. Advanced entries only. Deadline to enter is Saturday, September 5, 2020. Mailed entry must be postmarked by that date. No entries taken on grounds.

**HUNT** - Deadline to confirm entry at the grounds on Friday, October 30 is 6 p.m. ET. In Rounds 1 and 2 on Friday, dogs will be drawn out within their breed. Rounds 3 and 4 on Saturday will determine breed winners and overall in the hunt. Complete details posted on the UKC website.

**SHOW** - Deadline to confirm entry at the grounds on Saturday, October 31 is 11 a.m. ET. In Round 1, each dog is evaluated individually by three separate judges in three separate rings using a scoring system. Breed winners evaluated in Final Round using same method. Complete details posted on the UKC website.
