ROUTE TO THE SHOW

Purina Event Center (Purina Farms) is located 45 miles southwest of St. Louis in Gray Summit, Missouri. From St. Louis or Springfield, Missouri. Purina Farms is handy to reach from Interstate 44. Simply turn north at the Gray Summit exit (Exit 253) on Interstate 44, and travel two blocks on Missouri Highway 100. Go left on County Road MM, and the entrance to Purina Farms is one mile on the left. From Kansas City. Take I-70 east to the Warrenton exit at Hwy. 47. Go south on Hwy. 47 for approximately 25 miles until you reach Hwy. 100 in Washington. Turn left onto Hwy. 100 and continue to I-44 (approximately 10 miles). Go east on I-44. Follow the directions above from Springfield.
