



# RULES AND INFORMATION GOVERNING COONHOUND SINGLE REGISTRATION

**Option 1)** For single registration of a cross bred dog or a dog of unknown ancestry (if allowed by breed association). Dog must first meet criteria below or single registration will not be considered by UKC.

1. Dog must be at least one year of age.
2. Dog must have a complete three generation pedigree, either handwritten on this application or as an attached photocopy. This requirement may be waived by the national breed association.
3. Dog must be inspected and approved by a UKC National Breed Association Inspector. A breed inspector may not inspect or approve a dog he formerly owned. A breed inspector may not inspect or approve a dog produced by a male or female the inspector owned at the time of breeding. When meeting with the breed inspector, please provide the following:
  - a. Completed application
  - b. Registration fee. See section regarding fee on the front of this application
  - c. Stamped envelope, addressed to the national breed association coordinator.
  - d. Three color photos of the dog must be provided (one of each side and one from the front, all in a standing position).

*By signing this application, I understand and agree that any photographs I submit become the property of the United Kennel Club, Inc. and will not be returned. I give permission to the United Kennel Club, Inc. to use photographs of my dog in all forms of media, for any promotional purposes including publicity, display, advertising and editorial use.*

**Option 2)** For single registration of a dog produced by two UKC registered parents (Sire and Dam) who is NOT UKC litter registered and is over one year of age, the following rules apply:

1. Only the registrant of the dam (at the time of breeding as recorded by UKC) can register this dog or give their written authorization to register this dog to another individual.
2. The UKC number and the registered name of both the sire and dam (as listed on the UKC registration certificate) must be provided in Step 3 "Pedigree".
3. Three color photos of the dog must be provided (one of each side and one from the front, all in a standing position).

**If your dog does not qualify under Option 1 or Option 2,** your dog will not be considered for Single Registration with UKC.
