Read and Follow All Instructions

1. All applications for Single Registration must be made on United Kennel Club, Inc., application forms, which are furnished free of charge. Completed applications will not be returned to you.
2. All applications must be accompanied by proof that the dog is purebred. A copy of your dog's registration form issued by a registry acknowledged by United Kennel Club is normally sufficient proof of pure breeding. If you wish to inquire about the status of a registry, please contact the UKC Registration Department or visit our website at www.ukcdogs.com.
3. All applications must include two color photos of the dog unless approved by a UKC Field Representative. The photos need to be one of the dog standing in profile and one taken from the front. Photos must be sufficiently large (3" x 3" minimum) and clear so that our Single Registration Committee may fairly evaluate the dog. Photos will not be returned.
4. United Kennel Club, Inc., Registry is a separate and distinct registry and has no connection with any other registry.
5. The individual signing this application is solely responsible for the accuracy of the information contained therein.
6. United Kennel Club, Inc., reserves the right to correct or revoke any UKC Registration Certificate or Pedigree at any time.
7. Rules for single registration may vary depending on the breed of dog to be registered.
8. United Kennel Club, Inc., reserves the right to refuse any Application for Single Registration.
