Applications are furnished free of charge and can be photocopied as needed. Once submitted, all applications become property of UKC and are not returned. UKC reserves the right to refuse an application as well as correct or revoke any registration at any time. UKC reserves the right to change any and all rules, fees, etc. without notice.

The rules for Single Registration for the Cur/Feist breeds are as follows:

1. Completed UKC Application for Cur/Feist Single Registration is required for **all breeds**.
2. Copy of your dog's registration certificate from a UKC acknowledged registry if applicable. See breed specific requirements below.

Black Mouth Cur: Not required

Mountain Cur: Original Mountain Cur Breeders Association, Kemmer Stock Registry

Stephen's Cur: Stephen's Stock Registration

Treeing Cur: Not required

Treeing Feist: Not required

3. A complete three generation pedigree required for **Mountain Cur** and **Stephen's Cur** only.
4. Three color photographs. One photo of each side of the dog and one photo of the front must be provided for **all breeds**. Photos should be taken at eye level with the dog in a standing position.
5. Single Registration fee of \$20 made payable in US funds to UKC.
