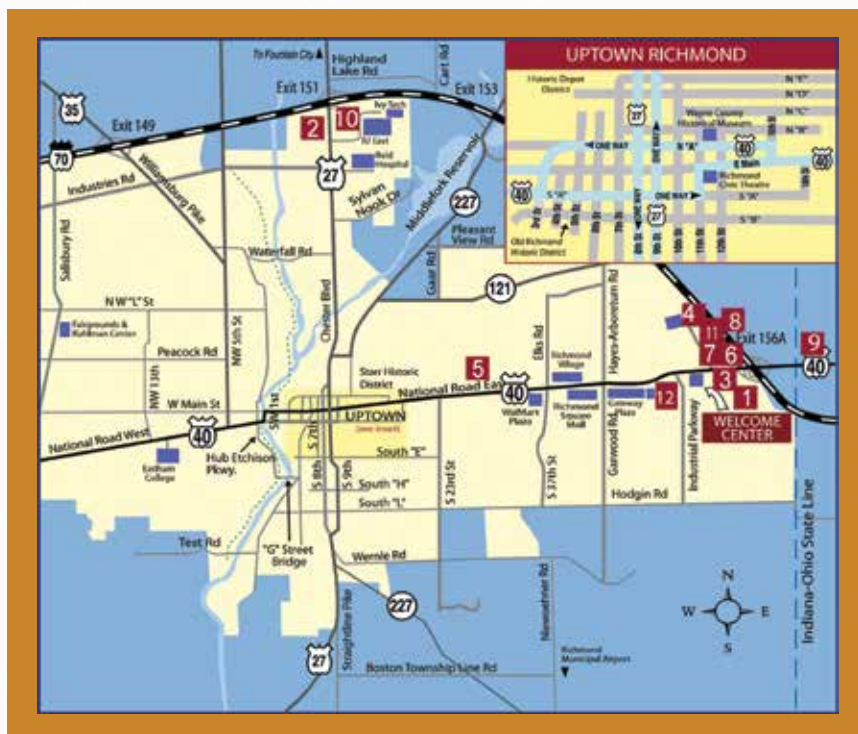

# HUNT RULES

1. Entries received before the advanced entry deadline, but after the pre-drawn limit of 300 dogs per night has been reached, will be placed on a "Wait List". They will be used to replace any "not confirmed" entries on predrawn casts. Any remaining and confirmed "Wait List" entries will be drawn to scorecards at Autumn Oaks. United Kennel Club reserves the right to combine casts if necessary.
2. **NEW THIS YEAR:** On-grounds entries will be accepted, based on available guides only. Hunting guide entries will be accepted, while non-guide entries will be considered on a first come first served basis. On-grounds entry fee is \$60. All on-ground entries must be submitted at the entry table by the 1:00 PM deadline each day. All Grand Nites must be entered for Friday.
3. **Refund Policy:** The entry fee will be refunded and mailed out to the owner of any confirmed "Wait List" entry that is refused due to unavailable guides. If a female comes in heat, another dog that is registered to the same individual may be substituted. No refunds. If a dog dies, the Registration Certificate may be turned in at the UKC registration desk. Another dog that is registered to the same individual may be substituted or a refund may be requested.  
**If a dog is injured and cannot hunt at Autumn Oaks, the owner must present a letter from a veterinarian on veterinary stationary and another dog that is registered to the same individual may be substituted. No refunds.**
4. Advance Entries. All entries must be postmarked or submitted online by midnight, midnight, August 14, 2020.
5. **Entry fee of \$40**, payable to United Kennel Club, must accompany each Nite Hunt Advanced Entry. **Major credit cards, certified checks, money orders or personal checks will be accepted. Online entries must be paid by a major credit card.**
6. Hunting Judges will be used on all casts. UKC reserves the right to assign non-hunting judges to any cast deemed necessary.
7. The same dog cannot be run more than one night. Dog must be run on the night scheduled. Switching is not allowed.
8. Thursday Dual Champion Hunt Entries **must** be confirmed at the UKC registration desk in the headquarters building by **6 p.m.** (local time). Friday and Saturday Entries **must** be confirmed at the UKC registration desk in the headquarters building by **1 p.m.** (local time), on the night scheduled to hunt. UKC will start entry confirmation at 11 a.m.
9. Any unbreakable ties to be determined via a coin flip with the exception of the Grand 16.

## CONFORMATION AND BENCH SHOW RULES

1. In the Conformation show, the dogs will be judged on the ground; there will be no benches in the ring. All of the dogs that make up the entry must be examined and gaited. Each breed will be judged separately. See complete details for this show on the previous pages.
2. **Pre-enter Bench Show and Conformation shows online at [ukcdogs.com/autumn-oaks](http://ukcdogs.com/autumn-oaks) and save \$5! Pre-entry deadline is August 14 by midnight.** Pre-entry fee is only \$25 per dog/entry with a free parking pass. Entries taken at the event will be \$30 with a free parking pass.
3. Refund Policy: Another dog that is registered to the same individual may be substituted. Changes or class move-ups will happen at the event. No refunds after advanced entries close.
4. Advanced Entries must be confirmed at the UKC Bench Show desk in the headquarters building starting on Wednesday during entry times and before the day scheduled to show. See schedule for times.
5. To be eligible for the **Dual Champions Class** the dog must have been a plus-point cast winner in the National Dual Championship Hunt. See page 30.

## GENERAL RULES

1. Buildings and Grounds will be open to exhibitors at 3 p.m. on Wednesday, September 2. Overnight security is not provided. All times are Eastern Daylight Savings Time.
2. Building and Grounds will be open to exhibitors at 7:30 a.m. Thursday-Sunday. Raper Center will close at 6 p.m. Wednesday-Saturday.
3. Dogs must **not** be left in the buildings overnight. All dogs must be out of the buildings by 6 p.m.
4. **ONLY** United Kennel Club registered dogs will be allowed on the grounds. Be prepared to show the UKC Registration Certificate if requested.
5. Limited barn space is available for dogs. Please respect your neighbors.
6. Individuals determined by UKC Staff to have an excessive number of dogs for the purpose of selling or trading and/or individuals with dogs not being cared for or in otherwise poor condition will not be allowed on grounds and will be ejected immediately if not in compliance.
7. No puppies/litters under 7 weeks of age permitted on the grounds.
8. Autumn Oaks, Inc., and Wayne County Coon Hunters are not responsible for loss, accidents or theft.
9. UKC provides clean up bags to be used for cleaning up after your dog. It is expected that everyone will be responsible for keeping their areas and the areas their dogs travel through clean.
10. UKC is not responsible for loss, accidents or theft. Absolutely no alcoholic beverages, firearms or illegal drugs will be allowed on the grounds or while participating in the hunt or in the buildings the day of a UKC licensed event.
11. **ATVs are strictly prohibited.** Golf carts (rented or private), motorized scooters and mopeds must carry proof of insurance at all times. All drivers must be of an age to have state issued driver's license. This will be enforced.
12. Free camping Thursday through Sunday. Pre-event camping fee collected at gate.
13. The Wayne County Fairgrounds is a designated non-smoking facility.
