

From Lumpkin GA go north on HWY 27 2.5 miles and take a right on James Lane Loop which is right next
to Oxford Asphault plant. Take the dirt road 1/4 mile and take a right.

Directions to High Cotton Farms, From Hannahatchee farm, S on 27 for 22 miles, turn left on lower Shellman rd for 0.2 miles, turn right on Doverel Hwy for 15.8 miles, left on Laing Crossroad for 3.4 miles. Enter gate 0.4 miles on right.

CLASSIFICATION: For this trial GUN SOLO and BRACES and OPEN SOLO and BRACES will be run. TAN and WRT will be run. This is a Walking Trial.

Subject to the specific information set forth herein, the SEEBGDC Field Trial Committee hereby adopts by reference and expressly incorporates the United Kennel Club Inc. Field Trial and TAN Rules and Regulations Standard Premium List Template Found within the OFFICIAL UKC POINTING DOG RULE BOOK using updates when they become available.

All owners and handlers must sign the release and waiver of liability which is a part of the entry form as a condition of being allowed to participate.

TRIAL AREA AND TYPE

The Field Trial will be conducted on native vegetation and planted vegetation habitat usual to the SW Georgia and SE Alabama upland bird ecosystem. The trials will be a Type W (wild) and L (liberated Bird) The handler is asked to read, be familiar with and abide by the Field Trial Rules as published by U.K.C.

The drawn running order is a *guideline* as to running order and time. Handlers and their dogs must be readily available at the judges' disposal to accommodate any change in running order. All dogs not needed for further judging will be excused.

ENTRY FEES

- A. OPEN or GUN Class Events \$50.00
- B. TAN or WRT \$50.00

SUBMITTING ENTRIES

- 1. Entries may be submitted on the Official U.K.C. Entry Form found on UKC site any current official U.K.C. Entry Form. Downloaded copies or photocopies of these forms may be used as well. All entries must be directed to Field Trial Secretary.
- 2. Entries must include the fully completed Entry Form and the associated fees. Entries received without fees will not be accepted.
- 3. Advance Entries must be received no later than 5:00 P.M. December 12, 2025. Entries tendered and accepted after that time must pay a \$10.00 late fee. The Field Trail Committee reserves the right to reject any late entry, depending up space, birds, logistics and other considerations. The running order of any dog entered late and after the drawing of the running order shall be solely at the discretion of the Field Trial Chairman and Secretary.

PAYMENT

- 1. Payment may be made by cash, check, or money order. No entry will be accepted without payment.
- 2. Make checks and money orders payable to "Moon Harvest Farms" or John Hutwagner. Checks and money orders must be payable in U.S. funds. Or Venmo entries to @john-hutwagner.

3. Post-dated checks or returned checks do not constitute a valid entry. A collection fee of \$35 will be added to the amount of each returned check or money order. Exhibitors who repeatedly submit invalid entry fees may be put on a CASH ONLY basis.

REFUNDS

- 1. No refund of entry fees will be made for entries cancelled after the Entry deadline, if an event is cancelled due to lack of entries or other consideration.
- 2. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Event Committee.
- 3. If, because of riots, civil disturbances, inclimate weather or other acts beyond the control of the host organization it is impossible to open or to complete a show or trial, no refund of entry fee may be made if necessary to cover non-refundable incurred expenses.
- 4. If, in the opinion of the host club, the well being of dogs, exhibitors or spectators is at risk due to extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, or pandemics, extreme heat, the host club may cancel or stop a show or trial before completion. No refunds will be made in such cases if necessary to cover incurred expenses.
