



# Appeal Form

This form is to be used **only** in the event a handler is not satisfied with a Panel ruling and wishes to file an Appeal with UKC. This Appeal form must be filed with a fee of \$20. The Appeal Form is not to be used in situations dealing with persons intimidating, threatening or injuring a hunter, Judges, Master of Hounds/Hunt Director, club official, or UKC Representative.

The appeal must be written out below. Use the back of the form or additional pieces of paper if necessary. **This form must be signed only by individual(s) making the Appeal and the UKC Licensed Master of Hounds/Hunt Director.**

This first page is to be sent to UKC along with the Official Hunt Report and Meeting Results form. The second page is to be retained by the sponsoring club, the third page is to be kept by the individual(s) making the appeal, and the fourth page is to be kept by the Master of Hounds/Hunt Director. Refer to the Official UKC Rulebook for the complete appeal procedure.
