UKC reserves the right to refuse an application as well as correct or revoke any registration at any time. UKC reserves the right to change any and all rules, fees, etc. without notice.

## Important Information and Rules Governing Single Registration

1. All applications must be accompanied by proof of registration with a UKC-acknowledged registry as well as a copy of a certified three generation pedigree from such registry of the dog applying for registration, or pedigrees of its sire and dam, must be attached. Acknowledged canine registries are CEB-US, the American Kennel Club (AKC) or UKC acknowledged foreign registry issuing certified pedigrees outside the United States.
2. The examination of the dog's lineage by CEB-US must verify at a minimum, that any non-UKC registered Epagneul Breton dog listed in the pedigree within a minimum of five (5) generations is a purebred Epagneul Breton registered by a UKC acknowledged registry.

4. Four color photos of the dog must be attached to this application. Please submit two photos from the side and two from the front, all in a standing position. Photos will not be returned and become property of UKC and CEB-US once submitted.
5. If this dog is approved for single registration, UKC will issue a UKC Registration Certificate, Three-Generation Pedigree, and Easy Entry Card with the right to subsequently correct, amend, or revoke such registration.
6. Although CEB-US in cooperation with the UKC will exercise reasonable diligence in verifying this dog's lineage so as to be eligible for single registration, it is the applicant's responsibility to submit sufficient documentation before the application can be approved. You may be contacted to provide additional information.
7. Prior to submitting this application, the applicant should carefully review the official UKC Epagneul Breton breed standard. To access the UKC breed standard, please type Epagneul Breton Breed Standard in the search engine. If the dog has any disqualifications listed in the UKC breed standard, the dog's application should not be submitted for full registration privileges. The applicant may however, submit a Limited Privilege (LP) application if the dog is spayed or neutered. Listing your dog in the LP program will allow participation in UKC performance events that the dog is eligible for.
