#### UKC TEAM IN THE FIELD

This Field Trial season is off to an exciting start! Building off that excitement is the Hall of Fame voting officially opening. Included in this publishing is the American Field Hall of Fame voting instructions. As always, each household receives two votes for personality and dog. As in the previous couple of years, the voting process remains the same, utilizing an online ballot. You will find the web address of the online ballot as well as a QR code linking you straight to your ballot. To get to the ballot, you may either type the web address into the browser on a laptop, desktop, or smart device or use the camera on your smart device to scan the QR code. Once you arrive at the form, you will be prompted to confirm your subscription status, and then you will find a list of all nominated parties listed twice each. Since each household is allowed two votes, you may select both instances of one name or select two different names. If the individual or dog you wish to vote for is not listed, there is also a write-in vote option.

This year, we will also be sending out weekly vote counts via our Hunting Ops email newsletter. To sign up, go to <a href="https://www.ukcdogs.com/email-newsletter">https://www.ukcdogs.com/email-newsletter</a>. These news blasts will go out each Tuesday, so if you sign up but don't see them in your inbox each week, make sure to check your spam folder.

I would also like to leave everyone with food for thought as they cast their ballots. Some of the criteria that one should consider when selecting a nominee are as follows:

For *Dogs*, their win record should reflect significance. Significance in consistency reflected by number of wins, and the caliber of the dog's performance reflected by the significance of the wins themselves. A nominee deserving of a vote should be one that elevated the level of competition in any stake they competed. Another major consideration is the quality of their progeny represented by the number of winners and the quality of their wins. In some situations, a dog may be considered solely based on its merits or the merits of its progeny when such is outstanding to the highest degree.

For *Personalities*, their various contributions to the sport are the major points for consideration. Their time in roles such as club official, breeder, owner, handler, reporter, scout, ambassador of the sport, and usually a combination of these over a considerable amount of time. It can be summed up by asking yourself these easy questions: "Is the sport of field trialing better for having this person in it?" and "Would the sport of field trialing be where it is today without their contributions?"

You will also find in this issue a list of the titles comprising this year's Election Committee. If you were involved in the change (incoming or outgoing) of any listed titles, please let us know to ensure Election Committee ballots go to the correct individuals in October. Please also let us know if there were any issues with your Election Committee ballot last year.

#### NBHA NATIONAL FREE-FOR-ALL CHAMPIONSHIP

Sycamore Creek Cody Named Champion; Erin's Gypsy Lady, Runner-Up

The NBHA National Free-For-All Championship commenced March 19 with Sycamore Creek Cody, owned by Bob Kelly, under the whistle of Zach Erne, being named champion. Erin's Gypsy Lady, owned and handled by Mathew Puckett, was named runner-up. The championship was judged by the watchful and experienced eyes of Dickie Sorrell and Eddie Smith. A huge thank you to all our sponsors who help the NBHA and trial hosts—Purina, Garmin, Gun Dog Supply, Gun Dog Central, Mule Brand Clothing, & Park Cities Quail Coalition.

Additionally, we would like to thank all participants, owners, and spectators who attended or supported this year's Free-For-All. These events wouldn't be possible without support from everyone in the local and NBHA community. Our judges, bird planters, dog wagon drivers, and kitchen staff deserve a special thank you for the long hours they spent making this a spectacular event for all involved.

Contested on the grounds of Croton Creek Ranch, the trial committee chose to run the central course for both the first series and the callback for the championship. This course runs across a sampling of western Oklahoma terrain and wild bird cover. Croton Creek Ranch boasts an ample population of wild quail. The amenities at Croton Creek boast a 20room hotel, three guest houses, a horse barn with plenty of stall space, turn-out pens, and a 7,200 sq. ft. event center (Social Barn) complete with game room, satellite TVs, commercial kitchen, and a dining room that seats 120 guests. The kitchen staff provided three meals a day,

and there was plenty of social time for contestants and spectators alike. 85% of the central course is viewable from one viewing area perched on a hilltop where the spectators can drive on top and park. Over 35 spectators came from across Oklahoma and the Texas Panhandle to watch some of the best dogs and handlers the NBHA has to offer to compete in this "Wild Bird" Country National Championship. Spectators got to see some up-close action, with some of the birdwork being flawless and some ending in the roading harness.

The weather was a mix of Oklahoma wind, rain, and good trialing weather. Scent conditions followed the weather patterns but were generally good throughout the trial until the second series, where weather and smoke affected scenting conditions.

#### First Series "Callback Dogs"

Piper started with a find at 5 and another at 20 on a running wild covey. Piper scored quickly again at 25 near the oil field location on the backside of course on a wild pair of quail. She scored one unproductive on the front side of course, below Willie's Ridge. Piper showed a big forward race and was named Top Qualifier going into the callbacks.

Rendrag's Red Line Finnley scored on three occasions during the hour bid. The ground race was a solid walking shooting dog race to the front.

Sycamore Creek Cody set the standard in the first brace with an eight-find performance! Running in windy, cool conditions, the birds were on the move,

and Cody was determined to point every one of them.

M V R Earl's Black Diamond had a big race, with two finds and a gutsy performance. The first find was at 20 at the end of the flats, where the course turns back right. Bracemate failed to back and circled several times, but he stood the pressure, and all was in order. The second find was on a small covey near the last creek crossing.

Erin's Gypsy Lady had three finds and a good race. The third find was below the dam crossing where birds hadn't been pointed.

Cates Rocket Girl had two finds. The first was on the right-side edge of the big bottom; the second was at time after a long relocation.

#### **Second Series**

Starting Tuesday, the Oklahoma weather decided it was done playing nice. The humidity dropped, the temperature was warm, and the wind blew out of the west. The dry, windy conditions contributed to a grass fire getting started in the Texas Panhandle, and by the second brace of the callback, the middle half of the course was inundated with smoke.

In Brace 1 were Sycamore Creek Cody and Rendrag's Red Line Finnley. At breakaway, the weather conditions weren't good and were getting worse. It was clear that the conditions would play a major factor in the outcome of the event and all of the dogs would be challenged on this the final series. At 3, point was called on the left side of the course in a known wild covey feeding location in some thick broom weed. Erne called point for Cody, and as the gallery moved nearer the action, we realized that Finnley was also pointed but obscured by the waist-high cover. Both handlers made an extensive flushing effort. Birds were heard talking to the right, likely a wild covey either running or feeding away from the dogs. Gardner made an effort to flush in the direction that birds were heard, but nothing was produced. At 10, both handlers decided to move on without relocating. Both dogs were moving well as we crested Willie's Ridge. Once over the ridge, the wind came into play, blasting handlers and dogs in the face as they dropped down into the creek and across the grass flats. Once on the flats, Finnley established herself on

the right side of the course, and Cody worked towards a loan thicket on the left. Cody's efforts were rewarded with a find in the thicket at 18. Cody showing bird-finding prowess in these tough conditions, proving the eight-find first series performance wasn't a fluke. Nearing the end of the flats, the course hangs a right with a series of draws, a known wild covey location on the left, and a ridge followed by a small but steep ravine and a known wild covey location on the right. Finnley went on point directly between these two points. Feathers and roost, but no birds were located. The gallery started seeing the smoke of a growing grass fire in the distance. The course drops down into another bottom and crosses a pond damn, and the setter disappeared into a small series of breaks to the front. The course turned right, and the scout was sent to check on Cody. Finnley, in the meantime, disappeared to the left of the course. Gardner sent his scout to the left side when birds were seen in the air. The scout found Finnley standing in the area where birds had been seen. By this time, Cody was making his way back to the front, and Gardner took Finnley on after the shot. Back on the front side of the course, both dogs worked diligently; the conditions on this side of the course were a little better as the wind and smoke weren't as bad. Cody, showing an ability to adjust to the thickets and brambles of Western Oklahoma, hunted gamely. At 50, Finnley pointed in a large thicket with the Setter backing. Gardner couldn't produce birds. Following relocation, birds were seen exiting the backside of the thicket. Both dogs finished the hour.

In Brace 2 were M V R Earl's Black Diamond and Piper. Despite tough conditions, both dogs were feeling good from the start. Both dogs were forward and several hundred yards to the front off of the breakaway. Diamond crossed Willie's Ridge straight to the front and going away. Piper staying a little right front and crossing the ridge near the spectator viewing area before swinging to the front. Both dogs hit the first creek crossing and

made strong moves out onto the grassy flats. This side of the course was filled with the smell of smoke from the distant fires. The wind was persistent and strong, and the temperature was warm but both dogs were showing a disregard for conditions. Diamond was matching his gutsy big running performance in the first series.

Piper was showing she was up to the task and in championship form, chewing up the grassy flats with big moves. At the end of the flats, Gardner called point. Piper was standing just 75 yards to the right of where Gordon had his first find in the first series. Diamond had disappeared over the hill immediately to the Shorthair's right as the gallery was riding to the find. Gardner began flushing efforts, and soon Diamond reappeared, and his quest for the championship ended with a failure to back. Unable to produce birds, Gardner took his dog on. At this point, the back side of the course was completely inundated with smoke. The Shorthair was gamely, covering the country but coming up empty in her quest for birds. As we once again crossed Willie's Ridge onto the front side of the course, the smoke wasn't as bad, but still no birds. With time dwindling, the shorthair was still strong and frantically searching for the game that had eluded her up to this point. With three minutes left in the brace and now on the overflow portion of the course, she swung and pointed. Gardner made every effort to flush but was unsuccessful. Time ended during an extended relocation effort, and the gutsy little Shorthair's chances at the championship were over.

#### **The Standby Dogs**

The standby dogs were called to the line, and the stage for the dramatic finish of the 2024 NBHA Free-For-All Championship was set. On breakaway, Cates Rocket Girl made a strong move to the front right, and point was called at 5. It wasn't meant to be, though, as a breach of manners ended the Setter's day early.

With his capable charge, Puckett topped Willie's Ridge and looked across the flats below, knowing what was before him. Erin's Gypsy Lady ("Maria") had 55 minutes left and had the course all to herself. The smoke had lightened on the backside of the course, but the wind was still there. Maria's range was slightly affected, but she was gamely searching all the right spots. She hunted for the next 25 minutes but with no luck, and then she was gone. Shortly after crossing the pond dam but before Willie's Ridge, she disappeared into a light series of breaks to the left of course, and didn't reappear. The scout was sent, and Puckett continued towards Willie's

Hill. The scout found Maria pointed, buried in a large thicket near where the Finnley, in Brace 1, had a stop to flush. Neither the gallery nor the handler could hear point being called due to the wind. In a twist of fate, the scout and dog could clearly hear Puckett calling. Maria's deep bond with her handler was too much and she left the birds to return to her handler! Up and over Willie's Hill and back to the front side of the course she went. As the handler and judges crested Willie's Hill at 40, Maria was seen to the front right of course standing. With birds at a premium on this day that a champion would be named, Puckett knew this might be his only chance. He flushed and flushed and flushed some more. Finally, at about 40 yards, he produced a bird in a small thicket, and everything was in order. Maria continued hunting every step for the remainder of the hour.

## 95th NEW ENGLAND OPEN SHOOTING DOG CHAMPIONSHIP & REGION 1 (AFTCA) AMATEUR ALL-AGE CHAMPIONSHIP

The 95th New England Open Championship commenced Monday, April 24, at 8 a.m. in cool overcast conditions. The Championship is hosted by the New Britain Field Trial Club and Association of New England Field Trial Clubs. It is the first leg of three consecutive events, which we promoted as "New England's Spring Fling Triple Header."

Beginning in 1934 and through 1949, the New England Bird Dog Championship was held on Hall of Famer (1959) W. Lee White's farm, also known as Championship Game Preserve on the White's Pinch Street homestead in Scotland, Connecticut. The grounds held grouse, woodcock, wild quail, and pheasant. In the early years, there seemed to have been a division between the traditional close-hunting New England grouse dog and the more wide-ranging Southern-type dog. Initially, qualifying stakes were held for the respective different type dogs. Eventually, a compromise was reached stabilizing standards. Then, beginning in 1967, the event settled in at Hall of Famer (1987), Harry Townshend's Ragged Hill Farm in Pomfret, Connecticut, where it thrived for 47 years. In 1972, for the first time in the event history, the Directors conceded to allow the limited use of horses by the handlers, and this move brought in a record entry at that time of 51 dogs. Hall of Famer Harold Ray (2006) won with Hall of Fame Setter Tomoka (1974). After Harry's passing, the event moved to its presentday location, the Dr. John E. Flaherty Field Trial Area in East Windsor, Connecticut.

Judges Tom Tracy, Lebanon, Connecticut, and Ronnie Rogers, New Market, Tennessee, named Pointer male Waybetter Rebel champion and Pointer male Miller's Heat Seeker runner-up champion. 

#### FIELD TRIAL SEASON NO. 150 COMMENCES

#### **Minimum Requirements for Field Trials**

The new field trial season has begun, and with the start of No. 150, it is timely to recall the sporting tradition we share and our obligation to promote and safeguard our time-honored sporting pastime.

Last season's wins are in the books; the victories, achievements, and perhaps the disappointments are a thing of the past.

Much of the game, as in most sporting pastimes, is luck — the luck of the draw, luck of the weather, luck when birds are moving, luck when your dog is "clicking just right." It's been that way since 1874, when the first recognized trial was held in October near Memphis, Tennessee.

Each new field trial season prompts optimism and enthusiasm. It is a new beginning, a fresh start. The advent of the 2024-2025 season provides an opportunity to review some pertinent items related to the field trial sport, among them the "Minimum Requirements," the basic regulations governing recognized field trials.

Club officers are responsible for ensuring that trials are conducted fairly and in conformity with the Minimum Requirements—their first and foremost duty. A list of these requirements is appended.

When the trial is completed, the results — names of the winning dogs, their owners, and handlers — are to be submitted to the United Kennel Club as soon as possible. Results received well after the trial (60-90 days) cannot be assured that the trial will receive suitable coverage. Trial results received six months after the conclusion of a trial will not be recognized. This is a great disservice to the winning dogs, their owners, and handlers.

• The No. 1 requirement is all-important for the recognition of a club's trial. The "Fixtures" columns carry the roster of upcoming recognized field trials. The name of the sponsoring club, the date and place of the trial, and the club official accepting entries must be shown in Fixtures at least 14 days before the trial date on the calendar at www.americanfield.com. Fixtures received well in advance will also appear in a print edition of UKC® Field.

All clubs hosting trials where placements may qualify a dog for championship competition are to publicize that trial with a suitable advertisement showing the date and place of the trial, location, time and date of the drawing, the stakes being sponsored, and the contact person (name, city, and state) who is accepting the entries.

- When owners and/or professional handlers enter dogs in a trial, they should provide full particulars (i.e., registered name and number of the dog, breed and sex, color, sire, and dam) for their entries on the entry form. Club officials are responsible for forwarding the winners' complete particulars. Owners and handlers can assist them by providing specific information on each of their entries.
- The number of dogs competing in a stake determines how many placements the judges may award. In stakes with three dogs entered and competing, one placement may be awarded; in stakes with four or five dogs entered and competing, the judges may award two placements; and in stakes with six or more dogs, three placements may be awarded. [A fourth-place dog is named in a few select events, the Futurities, for example.]
- For dogs to receive credit for their field trial placements, they must be registered with the Field Dog Stud Book.
- All dogs (and all breeds) winning a championship placement (winner or runner-up) shall be required to have DNA on file with the Field Dog Stud Book. That requirement was subsequently extended to all dogs winning open stakes, earning points toward the Top All-Age and Shooting Dog of the Year Awards. DNA kits (instruction sheet, swab to collect cell samples, and an application form) are available and will be sent on request.
- Dogs earning Derby placements shall only receive credit for that win when that dog is registered with the Field Dog Stud Book at the time the win is awarded. (An application in process with the Field Dog Stud Book shall be deemed meeting this requirement.)
- When a club announces its trial in the advertising columns of UKC® Field and on the website calendar, the "order of running" is the prescribed schedule to be followed. Clubs are to adhere to the published "order of running."
- Following the conclusion of the trial, particulars on the winners (name, number, breed, sex, etc.) should be forwarded to the United Kennel Club as soon as possible

within 30 days.

Any violation of the Minimum Requirements will result in the voiding of the trial and the placements awarded.

One last item pertains to the use of colored collars to distinguish two similarly marked or similar-appearing dogs. Custom dictates that the "top" dog shall wear the "red" collar and the "bottom" dog the "lime-colored" collar.

#### Minimum Requirements for Field Trials for All Pointing Breeds

As adopted by the Amateur Field Trial Clubs of America, the United Kennel Club, and the Field Dog Stud Book.

Wins will not be recognized and recorded unless the trial and/or each stake in which such win is made conforms to the following conditions:

1.) The name of the club, place, trial date, and the secretary's name and contact information must be listed on the calendar at www.americanfield.com at least 14 days before the trials are to be run. Information received well in advance will also appear in a print edition of UKC® Field.

#### 2.) Recognized stakes are:

Puppy Stakes: From January 1 to June 30 of each year for dogs whelped on or after January 1 of the year preceding, and from July 1 to December 31 of each year for dogs whelped on or after June 1 of the year preceding.

Derby Stakes: From July 1 to December 31 of each year for dogs whelped on or after January 1 of the year preceding, and from January 1 to June 30 of each year for dogs whelped on or after January 1 of the two years preceding.

All-Age: For dogs of any age. An "open" stake is one in which there are no limitations with respect to either dogs or handlers.

As defined by the By-Laws of the Amateur Field Trial Clubs of America, an "amateur" stake is one in which all handlers are amateurs. Winners in Members' and Shooting Dog All-Age Stakes will be recorded, but winners of Children, Ladies' Brace, and other stakes not conforming to the foregoing definitions will not be recognized.

Championships, Winners' Stakes, and

Futurities: Wins will be recorded only in such amateur events of this character as are recognized by the Amateur Field Trial Clubs of America and in such open events as are recognized by the United Kennel Club and the Field Dog Stud Book.

- 3.) The minimum length of heats for all stakes other than Puppy Stakes shall be thirty (30) minutes on the basis of the time that an average brace takes to negotiate the course. In the case of one-course trials, no more than eight (8) minutes of the thirty (30) shall be spent in the birdfield. The minimum length of heats for Puppy Stakes shall be fifteen (15) minutes.
- 4.) A stake must be drawn no later than the night before the day the stake is advertised to be run.
- 5.) Dogs shall not be substituted after the draw.
- 6.) Braces shall be run and handled as drawn unless given prior consent of the judges, which consent must not be given for the purpose of accommodating owners, handlers, or dogs that are not available when reached in the regular order of the draw. In the case of withdrawals, the bracemates of such withdrawn dogs may be run together at the judges' discretion. Bitches which come in season braced with a male are scratched.
- 7.) No entry shall be accepted after a stake is drawn.
- 8.) No more than one brace of dogs shall be run on a course or any part of a course at the same time, irrespective of whether the dogs are in the same stake or in different stakes.
- 9.) Stakes shall be run only on recognized game birds whose flight shall not be impaired by caging, hobbling, wing clipping, brailling, or in any other manner.
- 10.) Bitches in season shall not be permitted to run in one-course trials. In multiple course trials, they may start only if, in the opinion of the judges, it can be accomplished under conditions which will ensure absolute fairness to other entries. Bitches in multiple course trials must be drawn in season and braced with a female.

#### Electronic Recovery, Tracking, and Communication Device Rules

The sole purpose of using the retrieval/ recovery device in a field trial is to assist the handler in locating a dog that may be lost and which is deemed no longer in judgment. The UKC rules, as adopted by the AFTCA for the use of a dog recovery unit in all recognized stakes, are as follows:

1.) The collar and receiver are to be

used as received from the manufacturer. The collar may not have any capacity to receive any communication, including to shock, tone, vibrate, or to receive other behavioral commands from any receiver. The collar's sole intended purpose is to locate the dog. No modifications are to be made to the collar other than a name identification plate affixed. By design, the collar must have a flat surface against the dog's neck. All components, including the collar, are not to exceed nine (9) ounces.

- 2.) A receiver is any unit capable of receiving any signal from the collar, including but not limited to handheld devices, watches, and smartphones. ALL receivers in the gallery, including those in the possession of the host club's designee, are to be turned OFF. (No one in the gallery shall "track" a dog while under judgment).
- 3.) Neither the handler nor the scout may have a receiver in their possession while their dog is under judgment. All of their receivers are to be given to the judges or a person designated by the host club.
- 4.) No Outside communication No one shall communicate in any manner with the handler, scout, judges, or gallery members with any information obtained through the use of a recovery device while dogs are under judgment.
- 5.) A receiver may only be activated once judgment has concluded. If a dog is gone at time, that dog is still under judgment until such time as the judges indicate otherwise or the handler requests the receiver unit. Once a handler requests the receiver the dog is no longer in judgment.
- 6.) If a dog is lost from a previous brace, the handler or designee may use the receiving unit during the succeeding brace solely for the purpose of locating the lost dog. Once the dog is recovered the receiver is to be turned off.
- 7.) The use of a recovery device is at the discretion of the host club. It is the handler's responsibility if they choose to use one, to furnish the device. The running of the stake shall not be held up due to the lack of a recovery device.
- 8.) While competing, a dog shall wear no more than two collars. If a handler elects to use a recovery unit, the collar shall remain on during the entire time the dog is under judgment. Removal of a recovery collar during the competition will result in the disqualification of that dog.
- 9.) Companion collar shall be no more than 2 inches in width and not more than 5oz in weight, used as received from the manufacturer without alteration. The

only addition is that of an identification nameplate.

- 10.) It is the responsibility of the handler to give the judge or club designee the receiver unit in the OFF position. A violation shall be the disqualification of the offending handler from the stake (the handler's remaining dogs in that stake may be run by a handler of their choosing should they elect to do so, but the violating handler cannot participate in any way in the remainder of that stake and the dog in that brace cannot be considered for placement in that stake).
- 11.) Any person using a receiver to locate a dog currently under judgment must be reported to the stake manager immediately and the handler and dog are immediately disqualified from the stake. It is the responsibility of the host club to report in writing all violations of these rules to the UKC no more than seven days from the date of claimed occurrence. Failure to report violations can result in the suspension of the club's ability to host Field Dog Stud Book recognized events.

It cannot be reiterated too often that it is incumbent on club officials to ensure the integrity of the drawing and that they apprise trial participants of the rules governing the use of electronic devices at recognized trials.

### Rules, Regulations, and A Working Relationship for 100 Years

The American Field/UKC, Field Dog Stud Book (FDSB), and Amateur Field Trial Clubs of America (AFTCA) have had a working relationship for more than 100 years. Because of that relationship, American Field/UKC field trials, Open or Amateur, operate under the same rules, regulations, and minimum requirements.

Wise decisions were made long ago to keep rules, regulations, and requirements to a minimum and build standards, traditions, and policies around them. It has long been the policy that each Club's events follow the same set of simple rules. regulations, and requirements, regardless of location, so the results from their stakes are meaningful compared to similar stakes in other places. Relativity and relatability are critical components for competition or even when trying to improve the breed, which historically is the primary purpose of trials. When drawings occur in the same way when there is the expectation and reality that the rules, regulations, and standards will be followed, whether judging, handling, or running events, the sport remains familiar to all, and that encourages fair competition. The sport benefits where there is certainty and consistency and suffers with exceptions

and inconsistency.

When putting on an event, finding ways to work around them or make unique and uncommon interpretations of so few rules, regulations, and requirements for personal benefit is not particularly difficult or honorable and certainly not sustainable. Fortunately, the overwhelming majority of participants work positively within the spirit of our few rules because they have long realized that the discipline to remain true to the sport actually benefits the sport. When issues arise, the responsibility to interpret the same rules and regulations for Open events rests with the UKC, and Amateur events rest with the residing President of the AFTCA. Club officials who translate rules and regulations outside of tradition and longheld interpretation at their events do so at their own risk.

Each summer, trustees of the AFTCA meet to discuss, amongst other things, the rules, regulations, minimum requirements, and standards of our sport. Trustees bring hands-on experience in all facets of the sport from across the United States and Canada to meet on these issues. At that meeting, an American Field/UKC representative attends to contribute, advise, and discuss with the AFTCA Trustees and adopt the motions passed by the AFTCA so that the sport, Open or Amateur, remains one in purpose and function.

The following two resources are indispensable to help provide consistency

across our sport for all involved. Standards to Field Trial Procedure, Judicial Practice, Handler and Bird Dog Performance is available from the AFTCA and is a must-know for anyone investing time and effort in the sport. Ultimately, it is the responsibility of each participant to know and follow the rules and regulations. AFTCA Running Rules and Minimum Requirements are updated yearly and available on the AFTCA website. They can also be easily resourced by club members or trustees. Field trial clubs, event chairs, and participants are encouraged to have both at their disposal during all of their events

Field trial participants are advised to keep these pages for future reference.



#### **BUILDER'S RISK**

Builder's Risk (30-67-512) was one of the foundation sires that Bill Rayl (HOF) sought in his quest to develop outstanding field trial competitors and bird dogs. Builder's Risk had all the quality attributes that make an outstanding field trial bird dog: intelligence, a strong bird-finding desire, and endurance. These traits were passed on to his progeny and, through them, passed on from generation to generation. Builder's Risk produced 67 winners that have won 512 field trials. He produced three champions: Builder's Addition (HOF; 19-41-246), Builder's Free Boy (15-18-154), and Glendale.

Paraphrasing from John P. Russell's book, 'The Invitational Champions,' Builder's Risk (CH '1975), through his direct progeny, had a continuing influence in the Quail Invitational Championship. Through Builder's Addition (HOF; CH 1977, R-U 1978 and R-U 1979), Builder's Risk appears in either the sire or dam lines of Addition's Go Boy (HOF; R-U 1985), Lehar's Main Tech (HOF; CH 1994), Redemption's Reward (R-U 1989), House's Hiplain Drifter (CH 2003), Future Stock (CH 2002), House's Snake Bite (R-U 2008), Chinquapin's Andy (CH 2010) and Erin's Dog Soldier (CH 2014). And through Builder's Free Boy (R-U 1983) progeny, Builder's Risk appears in sire lines of Flatwood Rusty (R-U 1995) and Silverwood (HOF; R-U 1996).

It is apparent that Builder's Risk played an integral part in improving the pointing dog breed, A Champion of Champions!

Blessed with a beautiful stride and speed afoot to burn, Lacey went on to enjoy a successful competitive career, mostly in the Amateur Shooting Dog genre.

However successful Miller's Bring The Heat was as a performer, her second career as a brood matron is where her light really shone the brightest. She was bred three times to the same male, Ch. Just Irresistible. From these three matings came 18 dogs with currently 88 championship placements. These include a National All-Age champion and three National Shooting champions, both in Open and Amateur. With her record both as a performer and a producer, Miller's Bring The Heat is deserving of your consideration for the Field Trial Hall of Fame. — Dennis Hood

I enthusiastically endorse Miller's Bring The Heat ("Lacey") for the Bird Dog Hall of Fame. She was a competitive shooting dog with 20 wins, including R-U Champion in the 2017 Region 16 Amateur Shooting Dog Championship. Her record

is 20-18-227; 18 of her 20 offspring have already accumulated 227 placements. Of these, 52 are championships, and 36 are R-U championships, for a total of 88 Championship titles. Miller's Bring The Heat ("Lacey") was a runner-up champion with 20+ placements. Lacey was always a big, front-running dog and never failed to find game. She was ran sparingly to spend most of her time raising three litters of puppies. These litters produced 20 dogs-18 were winners on the field trial circuit with 52 championships and 36 runners-up. This does not include the overwhelming amount of classics, futurities, and other placements her offspring have received. These dogs won and placed in trials from Prairies to Edge Country and Piney Woods to Grouse Woods, all the while taking after their mother's traits of being big, frontrunning, classy bird dogs. I don't know what else can be said about what Lacy has contributed to the English Pointer breed. Eighteen of her 20 firstgeneration offspring have championship wins in Shooting Dog and All-Age and wins in major competition; many of these wins were National titles. This puts her in a field all by herself. To get this kind of consistency is unheard of. This same success is being passed down to the next generations. Fortunately, I had the privilege of handling and caring for three from her first litter (Nat. CH Miller Unfinished Business, CH Miller's Stray Bullet, R-U CH Miller's Bushwacker). I also had the privilege of breeding, training, and handling Senah's Back In Business (second generation) to a National Open Shooting Dog Championship title. I have trained and handled bird dogs for almost 50 years and recognize something special when I see it. There is no doubt that the dogs I competed with had limited opportunities to compete, but they were always consistent and made the most of it. We only ran a few major trials in the Southeast, but these dogs always were competitive, and the trial wasn't over until they ran. Lacy's blood ran strong through their veins! —Joel Norman

Miller's Bring the Heat may be the only female whose direct offspring have won the National Shooting Dog Championship (Miller's Unfinished Business) and the National All-Age Championship (Miller's Blindsider). She backed up that record when a grandson (sired by Miller's Unfinished Business) was named Champion at the National Shooting Dog Championship a few years later. As remarkable a record as that may be, it is exceeded by the phenomenal record of her offspring in total. To date, they have earned 88 Championship titles in quality amateur and open stakes, both for Shooting Dog and All-Age. She was very consistent. Each of her three litters has produced outstanding dogs, including four Purina Top Dog Awards. Her record will only get more impressive as the next generation of her dogs continues to earn titles. Miller's Newest Version (a dog of mine), for example, has already won three championship titles. Miller's Bring The Heat is very deserving of a place in the Hall of Fame. She has my very strong endorsement. — Bill Owen

Most of the time, when you consider a dog for the Hall of Fame, you consider the field trial wins and production record. Production records are almost exclusively a sire's territory just from the logistics of how many times a year you can breed a male versus a female. While Miller's Bring The Heat had a respectable field trial career, runner-up champion with 20 other placements, she proved her value to the breed as a producer. To date, she has produced 18 different dogs that have 52 championships and 36 runners-up, and this does not include other placements. She has produced four dogs that have won the Purina Award in their divisions, and she already has grandchildren with seven championships. She has produced dogs that have won across all categories of field trial competitions. It is very rare for a female to have this much of an impact on the breed. Please join me and elect this "Blue Hen," Miller's Bring The Heat, into the field Trial Hall of Fame. — Ray Pearce

The first dog that comes to my mind when thinking of Hall of Fame worthiness is Miller's Bring The Heat. A dog's record as a performer and producer is considered contributing to the sport by the quality of their achievements and their contributions to the pointing dog breed by the quality of their offspring. Lacey is exactly that! Lacey's talent was evidenced early on as she competed and won around the country. A trial was never over until she had run. Little did the Millers know that the breeding to CH Just Irresistible would be lightning in a bottle three times! These breedings may go down as THE BEST in the history of our sport! I have firsthand knowledge of her offspring. My father, Neil Walker, and I are lucky to own one of her sons, CH Miller's Unbridled Forever. To date, he has 27 placements; 14 are championship titles. We thank the Millers for the opportunity to own one of these fine dogs. Lacey produced the most natural front-running bird dogs I have ever seen. Let's get this very worthy and deserving candidate into the Hall of Fame! — Brian Sanchez

I love every aspect of raising, training, and competing with bird dogs. Believe it or not, I have actually bred and raised a few winners. But I can only dream of the success that Jack and Fran Miller had with Runner-up Champion Miller's Bring The Heat. "Lacey" was a true field trial winner and a Blue Hen. She was a runner-up champion with 20 field trial placements. Her offspring have won and are still winning almost every championship there is in our field trial world. Her grandkids are now leaving their mark, with several Futurity and championship wins.

Ch. Just Irresistible was a very worthy addition to the HOF. He was a great

competitor and sire; Miller's Bring The Heat was a very large part of this success. The three litters they produced have left a mark on this sport that will not soon be forgotten. If there was ever a dog that completely describes the very being of a Hall of Fame Inductee, it is Runner-up Champion Miller's Bring The Heat. Please help me in getting Miller's Bring The Heat elected into the HOF. — Darrell Wells

#### RIVERTONS FUNSEEK'N SCOOTER

Several years ago, when Richie Robertson would make the trip from Idaho to South Georgia for the winter, we would work dogs together. He always had a running dog, but first and foremost, he had a dog that worked for him and hunted. One winter, Rich was in town with some derbies to work. This would be my first time seeing "Scooter." He shined like the star he would become. Pointing birds, running with ease in the South Georgia cover like he had been there all his life. That was Scooter, at home in any terrain that possessed game birds. I watched him run from the Dakota prairie to the sandhills of Florida. He always ran with power and pointed birds no matter the conditions, always teaching me something. I had the opportunity to work dogs out of Scooter and out of his offspring. They carry his strength and desire to find game. These dogs have played a major role in my dog training career and continue to do so. With Scooter's impressive win record, along with the influence his offspring continue to have on our sport, I ask for your vote to put Scooter where he belongs: in our Hall of Fame. — Judd Carlton

Scooter had the respect as a competitor and also as a breeder. He was a competitor from the West Coast to the Prairies to the Deep South. Not many dogs can make this transition of different terrains. Scooter could figure out different types of wild bird country in a short time and be a competitor; I also used him to guide wild bird hunting. He knew the difference between trialing and foot hunting. His legacy continues to live on through his progeny; his list of winning dogs continues through three generations of his bloodline. Look at what he has passed on in the breed and what he has done for the sport of field trials.

Here is a list of winning dogs that he has sired: Ch. Just Irresistible, Ch. Dominator's Rebel Heir, Ch. Funseek'n Hit Man, Ch. Little Willow Aaron, Ch. Painted Nickel Mac, R-U Ch. Just Watch, R-U Ch. Just Unforgettable, R-U Ch. Wait A Minute, R-U Ch. Born On Fourth July.






