

## OFFICIAL UKC CHANGE OF ADDRESS FORM

**UKC Address Change Policy:** All address changes must be submitted in writing and must include the appropriate signatures authorizing UKC to make this change. For your protection this information will not be accepted over the telephone. There is no fee to update your address with UKC but there is a fee for issuing corrected registration documents. You are not required to have your documents reprinted. Dogs that are registered at UKC in partnership with an "and" or "or" between the owners' names will require the signatures of both owners. Dogs that are registered with a designated Sole Signatory at UKC will require the signature of the Sole Signatory.
