



### Step 3 Rules & Inspection - IMPORTANT INFORMATION & RULES Governing Feist Single Registration

The rules for Single Registration for the Feist breeds are as follows:

1. Completed UKC Application for Feist Single Registration is required for **all breeds**.
2. Mountain Feist and Treeing Feist will be required to show proof of registration from an acknowledged registry to the breed inspector.
3. A copy of your dog's official/certified pedigree from either National Kennel Club or American Treeing Feist Association must be provided for the pedigree to be acknowledged.
4. Three color photographs. One photo of each side of the dog and one photo of the front must be provided for **all breeds**. Photos should be taken at eye level with the dog in a standing position.

**X-BRED FEIST: (a dog will be registered as an X-Bred Feist when it is...)**

- a cross between two different UKC recognized Feist breeds
- a cross between a UKC X-Bred Feist and a UKC recognized Feist breed
- a cross between two UKC X-Bred Feist
- a dog exhibiting a disqualification for a UKC recognized Feist Breed
- a UKC recognized Feist breed unable to provide proof of registration from an acknowledged registry

**Breed Inspector Section To be completed ONLY by UKC Breed Inspector**

(Sole Signatory/ Registrants: Do not write in this area.)

Once inspection has been completed, the breed inspector must complete and sign this section. The inspector will then mail the application, fees, and any additional registration documents to UKC. **Mountain Feist and Treeing Feist will be required to show proof of registration from an acknowledged registry to the breed inspector.**

**I attest that:**

- 1) I am qualified to serve as a UKC Breed Inspector, being a MFA appointed breed inspector or UKC Staff Member.
- 2) I am sufficiently familiar with the UKC breed standard to evaluate the dog whose information is recorded here;
- 3) I have visually inspected this dog and have found it to meet its UKC Breed Standard without exhibiting any disqualifications;
- 4) I have been presented with the proper documentation signifying this dog is eligible for UKC Registration; and
- 5) I do not own this dog, and did not own its sire or dam at the time of breeding.
