**NOTE:** Altered Group competition will not be offered. Altered Breed winners will automatically advance to Altered Best in Show. Best In Show Judges to be announced immediately prior to the judging of Best in Show.

**Entry Limits:** Obedience will be limited to 30 entries per day, and Rally Obedience will be limited to 60 entries per day.

**Total Dog/Total Junior:** Offered each day. To qualify, exhibitors need at least one Conformation win and one Performance qualification on the same day to qualify for Total Dog and Total Junior. Wins do not carry over to the next day. Altered dogs may compete in Altered Conformation for an Altered Total Dog Award.

**PREMIER Total Dog Qualifier!** Any dog that earns a Total Dog at the 2019 Washington Classic will automatically be added to our Total Dog Groups at the 2020 UKC PREMIER Event. Classic qualifiers must enter at least one event at PREMIER and submit their Classic Total Dog invitation with their entry.

**Non-Licensed Classes:** Non-Licensed Veteran and Puppy classes will be offered for each show and will show after the licensed classes for their breed. Breed winners will automatically advance to Best Veteran/Puppy in Show competition. Cost of entry is \$10. Entries into this class will be taken day of show only. Dogs do not need to be permanently registered with UKC or have a Temporary Listing (TL) number in order to compete in Novice Puppy.

## GENERAL INFORMATION

- This event is outdoors. Conformation will be held outdoors on grass. All performance events are held in the covered arena.
- Please remember to keep all grooming to a minimum per UKC rules.
- Grounds will be open to exhibitors by 7 a.m. on Friday, June 28. Overnight security is not provided, and no dog(s) may be left unattended overnight.
- All event times are Pacific Time.
- There will be absolutely NO SMOKING and NO VAPING in all buildings, on the show lawn, or around the designated crating areas. No smoking or vaping within 25 feet of any shade canopies.
- No general admission or parking fees will be charged.

## ENTRY FEES

### Pre-entry & Pre-entry Specials

Pre-Entries must be submitted via UKC's online entry system, mail, or fax. Pre-entries will be opened on Monday, May 6, 2019 at 8:00 a.m. Eastern time. All pre-entries must be received by UKC by Wednesday, June 5, 2019, 4:30 p.m. Eastern time. No pre-entries will be accepted or processed after that time.

### Pre-Entry Fees:

1. Conformation: \$25; \$120 special for same dog entered in all 6 shows.
2. Agility: \$25, \$120 special for same dog entered in 6 runs.
3. Obedience: \$25, \$60 special for same dog entered in all 3 trials.
4. Rally Obedience: \$25, \$60 special for same dog entered in all 3 trials.
5. Junior Showmanship: No Charge

### Day-of-show Entries:

1. Conformation: \$30 per show
2. Agility: \$30 per trial, \$25 second entry of the same dog into the same trial.
3. Obedience: \$30 per trial, \$25 second entry of the same dog into the same trial.
4. Rally Obedience: \$30 per trial, \$25 second entry of the same dog into the same trial.
5. Junior Showmanship: No Charge
6. Veteran: \$10 per show
7. Novice Puppy: \$10 per show

## ROUTES TO THE SHOW

Argus Ranch Facility for Dogs, 35612 212th Way SE, Auburn WA 98092, 253.333.2347

**From North or South End:** Take I-5, I-405, SR-167 to Highway 18 eastbound. Take Auburn-Black Diamond Rd eastbound exit. Turn Right onto Auburn Black Diamond Rd. Turn RIGHT onto SE Green Valley Rd (just past Neely Mansion). Follow for about 7.5 miles. Turn RIGHT onto 212th Way SE. Go over bridge take First LEFT into Argus Ranch and follow drive straight ahead to Arena and parking.

**From Hwy. 410 or WA 164 (Auburn-Enumclaw Hwy.):** Turn LEFT onto 244th Ave SE (approximately one mile out of Buckley). Go STRAIGHT at Light on SE 436th Way/WA-164. Go STRAIGHT at Stop Sign SE 416th St. Go STRAIGHT at Stop Sign SE 400th St. Turn LEFT at Stop Sign onto SE 384th St. Turn RIGHT at Stop Sign 212th WAY SE. Turn RIGHT at ARGUS RANCH Sign (just before Bridge). Follow drive STRAIGHT ahead to Arena and signed parking.

**From SR 169 Southbound:** Right onto Roberts Dr (in front of the Coal Car), go approximately four miles. Left onto 218th St. At bottom of the hill is a stop sign. Go straight across over cement bridge (Whitney Bridge). Take First Left into Argus Ranch and follow drive straight ahead to Arena and signed parking.

**From SR-169 Northbound.** Turn LEFT onto SE Green Valley Rd (in front of the Boondocks Nursery). Go about four miles. Turn LEFT onto 212th Way SE. Go over the Cement Bridge. (Whitney Bridge). Take First LEFT into ARGUS RANCH and follow drive straight ahead to Arena and signed parking.
