Conformation wins include any of the following wins over competition: Best Male/Female, Best of Winners, Champion, Reserve Champion, Grand Champion, Reserve Grand Champion, Group 1-4, Best in Show, Reserve Best in Show.

On Saturday, Veteran and Novice Puppy will be held before Best in Show (Show 2).

Non-Licensed Classes:

Non-License Veteran and Puppy classes will be offered in Show 1 on Saturday and will show after the licenses classes for their breed. Novice Puppy and Veteran breed winners will advance directly to their respective Best in Show class. The cost of entry is \$15. Dogs do not need to be permanently registered with UKC or have a Temporary Listing (TL) number to compete in Novice Puppy. All Non-Licensed entries must be received by 8:00 am on Saturday.
