THURSDAY, JUNE 16, 2022 | PROGRAM OF JUDGING: 2021 TOP TEN FINALS COMPETITION

The Top Ten dogs in each breed were invited to compete in this year's Top Ten Invitational, based on the points earned at UKC-licensed Conformation shows during the 2021 calendar years. There are 373 dogs entered in this competition, representing 129 breeds. The assigned judges for the Semi-Final and Final rounds will not be announced prior to judging. The same armbands will be used for the Premier Nationals and Top Ten and All Stars. Winners of each round must keep their armband to compete in the next round. It is the exhibitor's responsibility to have their dog ringside at the time of judging. Judges are not required to wait for dogs.

3. Any corrections to entries must be made in writing to UKC using the appropriate form provided not later than one half-hour prior to the start of any regular judging at the show.

TOTAL JUNIOR – AWARD OF MERIT

To qualify as a Total Junior, a Junior Handler must earn a placement with competition or an Award of Merit in Junior Showmanship on Saturday, June 18, 2022.

The Award of Merit for UKC Junior Showmanship classes will be calculated as follows:

TOTAL DOG AWARD

To qualify as a Total Dog, a dog must compete in Regular or Altered Conformation on Saturday, June 18, 2022 and win one of the following awards over competition: Best Male/Female of Variety, Best Male/Female, Best of Winners, Champion, Reserve Champion, Champion Award of Merit, Grand Champion, Reserve Grand Champion, Grand Champion Award of Merit, Best of Breed, Group 1 through 4, Best In Show, or Reserve Best In Show.

The following addition to the existing Total Dog Rules regarding Awards of Merit for the Champion and Grand Champion classes shall apply solely on Saturday, June 18, 2022.

Champion and Grand Champion Award of Merit (AOM) shall count toward competition win when computing a total dog qualifier. The number of Awards of Merit to be awarded shall be calculated as follows:

- 5-9 dogs in competition – 1 AOM
- 10-14 dogs in competition – 2 AOM
- 15-19 dogs in competition – 3 AOM

The dog must also earn a qualifying score in a Performance event on Friday, June 17, 2022. Eligible Performance events include Agility, Obedience, Rally Obedience, Nosework, Lure Coursing, Drag Racing, Dock Jumping, and Weight Pull. (*Precision Coursing does not count toward Total Dog.*)

General Building and Parking Information

1. Building and Grounds will be open to exhibitors at 3:00 pm on Tuesday, June 14, 2022. Overnight security is not provided. All times are Eastern Daylight Savings Time.
2. Building and Grounds will be open to exhibitors at 6:30 am on Thursday and 7:00 am on Wednesday, Friday - Sunday. Building will close at 10:00 pm Wednesday-Saturday. On Sunday, the building will close 30 minutes after the conclusion of Best of the Best or 6:00 pm, whichever is later.
3. Please follow the directions of the parking attendants to facilitate an orderly traffic flow through the unloading and parking areas. Vehicles are allowed a 15-minute unloading time. Violators will be towed.
4. Available grooming space is on a first come, first served basis. Empty grooming space may not be saved. Crating reservations are available until June 6, 2022.
5. No rugs or ground cover mats are allowed on the floor.
6. No exercise pens inside any building. There is ample room for private ex-pens outside.
7. Exhibitors will be required to stack their crates when crating in buildings.
8. Dogs may not be left unattended when on a grooming table or crated in soft mesh crates. No dog may be left in an unlatched or un-zippered crate.
9. Dogs must not be left in the buildings overnight. All dogs must be out of the buildings by 10:00 pm.
10. No dogs or pets of any kind in restrooms or showers.
11. No foreign substances allowed on dogs.
12. For Conformation, small ringside tables and crates are only allowed at ringside during the judging of a single breed. The Event Committee may order these tables and crates to be removed at their discretion. Please do not abuse this privilege.
13. There will be absolutely NO SMOKING/VAPING in any building or designated areas.
14. No cones or other means may be used to save parking spaces in or about the parking lot or campgrounds.

Exhibitor and General Information

1. All events are held under the Rules and Regulations of the United Kennel Club.
2. UKC, its agents, and its employees assume no responsibility for any loss, damage, or injury sustained by spectators, exhibitors, and/or handlers, or to any of their dogs or property, and further assume no responsibility for injury to children not under the control of their parents or guardians. UKC is not responsible for loss, accidents, or theft.

Ring Conflicts

- Exhibitors are responsible for being available for judging at the scheduled time.
 - Every possible effort will be made to accommodate exhibitors who have dogs entered in multiple events, but judges are not required to wait for dogs. Exhibitors are advised to notify stewards in all rings affected by the conflict so judges may work around any conflicts more easily.
 - **All Stars exhibitors:** please be advised the Agility, Obedience, Rally Obedience, and Drag Racing All Stars Invitationals are not required to make allowances or accommodations for dogs or handlers entered in the All-Star competition and any other event.
3. UKC encourages exhibitors to present their dogs with the least amount of grooming necessary to enable a judge to properly compare each dog with its breed standard. Dogs should be clean, have clean teeth, and have nails cut to a length suitable for the dog to perform the work for which it was bred. UKC enforces rules against artificially altering pigment, coat color, and coat texture with products, surgical alterations, or other means as outlined in the Official UKC Rules for All-Breed Events. The judge's determination that this rule has been violated shall be final.

4. The owner or designated handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. The host organization, event committee, and superintendent have no obligation or responsibility for providing service through a public-address system, stewards, or runners for locating dogs that are not brought into the ring when required.
5. No unentered dogs allowed on the event grounds. No dog less than 8 weeks of age may be present on the grounds of a UKC licensed event.
6. Exhibitors and dog owners are expected and required to clean up after their own dogs. Any person witnessing a violation of this rule must report it to the Event Committee. The Event Committee may ask any person violating this rule to leave the event grounds. No refund will be made if an exhibitor is asked to leave the grounds.
7. ATVs (4-Wheelers) are prohibited on the grounds of the Kalamazoo County Fairgrounds.
8. No bicycles are allowed in any building or directly around any event ring. Failure to adhere may result in the expulsion of the cyclist from the Event Grounds.
9. Skateboards and roller blades are allowed in the camping area only.
10. UKC will vigorously support any lodging facility that files a complaint about exhibitors who fail to keep their dogs quiet or to clean up after them. UKC will take disciplinary action against any offenders.
11. All rights to televise, videotape, advertise, photograph, promote, or otherwise exploit the event are vested in United Kennel Club and its assignees. All persons and animals on the event grounds at any time while the shows are in progress do, by attending these shows, grant to the club the right to photograph, televise, videotape, audiotape, or otherwise use their likeness and voice in any manner without further release or consent.
