 - 3. Set-up.** You may begin setting up crates inside and outside on Tuesday at 3:00 pm. Those who have reserved indoor crating or grooming spaces will be allowed in the building at this time.

1. Owners are responsible for the accuracy of information on the entry forms. Owners are responsible for any errors made on entry forms, regardless of who may make such errors. Owners and exhibitors are responsible for correcting any errors on their entry.
2. If, according to the owner's records, dogs that have completed the requirements for a title after the closing of entries may be moved up from the entered class to the class for which it is eligible. All corrections or changes to entries must be made by filling out a UKC Class Change/Correction form no later than 7:30 am of the day you wish the change to take place. Any corrections to entries must be made in writing to UKC using the appropriate form provided not later than one half-hour prior to the start of any regular judging at the show.

TOTAL JUNIOR – AWARD OF MERIT

To qualify as a Total Junior, a Junior Handler must earn a placement with competition or an Award of Merit in Junior Showmanship on Saturday, June 13, 2026.

The Award of Merit for UKC Junior Showmanship classes will be calculated as follows:

*Award of Merit will only be given if the individual class meets these requirements.

- 6 Junior Handlers in competition 1 AOM
- 9 Junior Handlers in competition 2 AOM
- 12 Junior Handlers in competition 3 AOM
- 15 Junior Handlers in competition 4 AOM
- 18 Junior Handlers in competition 5 AOM
- 21 Junior Handlers in competition 6 AOM
- 24 Junior Handlers in competition 7 AOM
- 27 Junior Handlers in competition 8 AOM

The Junior Handler must also earn a qualifying score in a Performance event on Friday, June 12, 2026. Eligible Performance events include Agility, Obedience, Rally Obedience, Nosework, Lure Coursing, Dock Jumping, Weight Pull, and Precision Coursing & Dash.

TOTAL DOG AWARD

To qualify as a Total Dog, a dog must compete in Regular or Altered Conformation on Saturday, June 13, 2026 and win one of the following awards over competition: Best Male/Female of Variety, Best Male/Female, Best of Winners, Champion, Reserve Champion, Champion Award of Merit, Grand Champion, Reserve Grand Champion, Grand Champion Award of Merit, Best of Breed, Group 1 through 4, Best In Show, or Reserve Best In Show.

The following addition to the existing Total Dog Rules regarding Awards of Merit for the Champion and Grand Champion classes shall apply solely on Saturday, June 13, 2026.

Champion and Grand Champion Award of Merit (AOM) shall count toward competition win when computing a total dog qualifier. The number of Awards of Merit to be awarded shall be calculated as follows:

- 5-9 dogs in competition – 1 AOM
- 10-14 dogs in competition – 2 AOM
- 15-19 dogs in competition – 3 AOM

The dog must also earn a qualifying score in a Performance event on Friday, June 12, 2026. Eligible Performance events include Agility, Obedience, Rally Obedience, Nosework, Lure Coursing, Dock Jumping, Weight Pull, and Precision Coursing, Steeplechase & DASH.

General Building and Parking Information

1. Building and Grounds will be open to exhibitors at 3:00 pm on Tuesday, June 9, 2026. Overnight security is not provided. All times are Eastern Daylight Savings Time.
2. Building and Grounds will be open to exhibitors at 6:30 am on Thursday and 7:00 am on Wednesday, Friday - Sunday. Building will close at 10:00 pm Wednesday-Saturday. On Sunday, the building will close at 6:00 pm.
3. Please follow the directions of the parking attendants to facilitate an orderly traffic flow through the unloading and parking areas. Vehicles are allowed a 15-minute unloading time. Violators will be towed.

4. Indoor grooming reservations will open online on Wednesday, May 27th at 8:00 a.m. E.T. Reserved spaces will be \$75 per 6x8 space for the week of Premier. If you would like conjoined spaces, they must be purchased in the same transaction. Any unsold grooming spaces will be available on a first come, first served basis. Empty grooming space may not be saved. Crating and grooming will be available in Expo South. The crating and grooming layout must be followed.
5. Open crating space will be available in the Rally and Obedience rooms for dogs entered in those sports. No grooming will be allowed in those spaces.
6. No rugs or ground cover mats are allowed on the floor.
7. No exercise pens inside any building. There is ample room for private ex-pens outside.
8. Exhibitors will be required to stack their crates when crating in buildings.
9. Dogs may not be left unattended when on a grooming table or crated in soft mesh crates. No dog may be left in an unlatched or un-zipped crate.
10. Dogs must not be left in the buildings overnight. All dogs must be out of the buildings by 10:00 pm.
11. No dogs or pets of any kind in restrooms or showers.
12. No foreign substances allowed on dogs.
13. For Conformation, small ringside tables and crates are only allowed at ringside during the judging of a single breed. The Event Committee may order these tables and crates to be removed at their discretion. Please do not abuse this privilege.
14. There will be absolutely NO SMOKING/VAPING in any building or designated areas.
15. No cones or other means may be used to save parking spaces in or about the parking lot or campgrounds.

Exhibitor and General Information

1. All events are held under the Rules and Regulations of the United Kennel Club.
2. UKC, its agents, and its employees assume no responsibility for any loss, damage, or injury sustained by spectators, exhibitors, and/or handlers, or to any of their dogs or property, and further assume no responsibility for injury to children not under the control of their parents or guardians. UKC is not responsible for loss, accidents, or theft.
3. UKC encourages exhibitors to present their dogs with the least amount of grooming necessary to enable a judge to properly compare each dog with its breed standard. Dogs should be clean, have clean teeth, and have nails cut to a length suitable for the dog to perform the work for which it was bred. UKC enforces rules against artificially altering pigment, coat color, and coat texture with products, surgical alterations, or other means as outlined in the Official UKC Rules for All-Breed Events. The judge's determination that this rule has been violated shall be final.
4. The owner or designated handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. The host organization, event committee, and superintendent have no obligation or responsibility for providing service through a public-address system, stewards, or runners for locating dogs that are not brought into the ring when required.
5. No unentered dogs allowed on the event grounds. No dog less than 8 weeks of age may be present on the grounds of a UKC licensed event.
6. Exhibitors and dog owners are expected and required to clean up after their own dogs. Any person witnessing a violation of this rule must report it to the Event Committee. The Event Committee may ask any person violating this rule to leave the event grounds. No refund will be made if an exhibitor is asked to leave the grounds.
7. ATVs (4-Wheelers) are prohibited on the grounds of the Kalamazoo County Fairgrounds.
8. No bicycles are allowed in any building or directly around any event ring. Failure to adhere may result in the expulsion of the cyclist from the Event Grounds.
9. Skateboards and roller blades are allowed in the camping area only.
10. UKC will vigorously support any lodging facility that files a complaint about exhibitors who fail to keep their dogs quiet or to clean up after them. UKC will take disciplinary action against any offenders.
11. All rights to televise, videotape, advertise, photograph, promote, or otherwise exploit the event are vested in United Kennel Club and its assignees. All persons and animals on the event grounds at any time while the shows are in progress do, by attending these shows, grant to the club the right to photograph, televise, videotape, audiotape, or otherwise use their likeness and voice in any manner without further release or consent.

Ring Conflicts

- Exhibitors are responsible for being available for judging at the scheduled time.
- Every possible effort will be made to accommodate exhibitors who have dogs entered in multiple events, but judges are not required to wait for dogs. Exhibitors are advised to notify stewards in all rings affected by the conflict so judges may work around any conflicts more easily.
- **All Stars & Hall of Fame exhibitors:** please be advised the Agility, Obedience, and Rally Obedience All Stars Invitationals along with the Nosework Hall of Fame are not required to make allowances or accommodations for dogs or handlers entered in the All-Star competition and any other event.

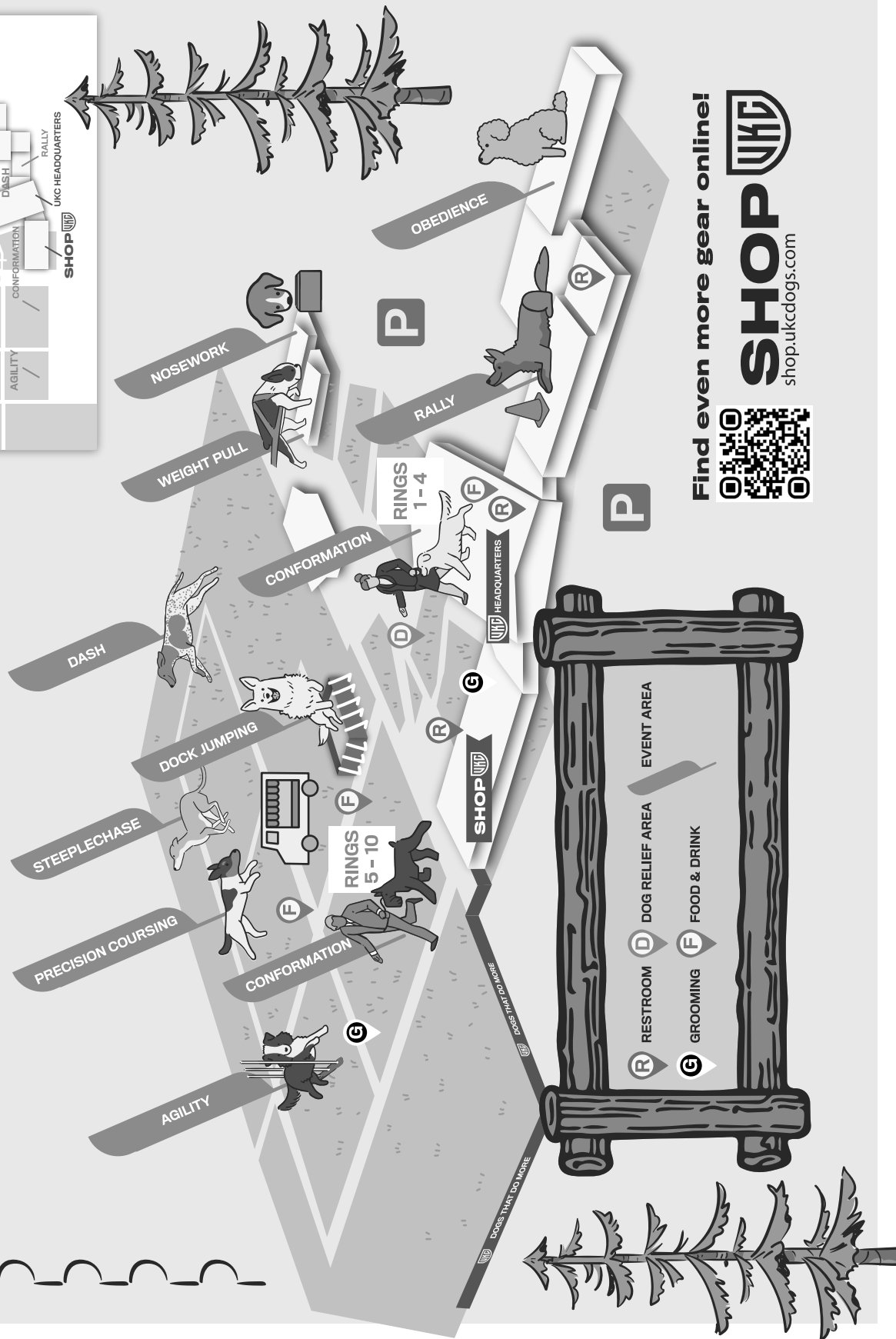
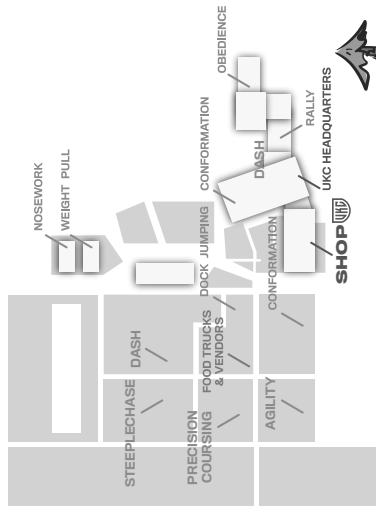

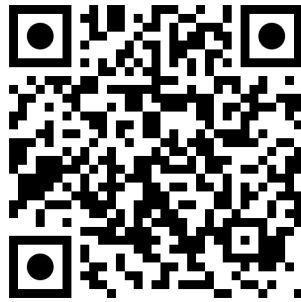
