Entry Limits: Obedience will be limited to 30 entries per day, and Rally Obedience will be limited to 60 entries per day.

Total Dog/Total Junior: Offered each day. To qualify, exhibitors need at least one Conformation win and one Performance qualification on the same day to qualify for Total Dog and Total Junior. Wins do not carry over to the next day. Altered dogs may compete in Altered Conformation for an Altered Total Dog Award.

Total Dog Invitational Qualifying Event! Any dog that earns a Total Dog at the 2020 Virginia Classic will automatically qualify to enter the Total Dog Invitational event to be held in October of 2021 and compete for a grand prize of \$10,000! Entry forms for the Total Dog Invitational will be sent in August 2021.

Puppy Matches: A puppy match will be held each day. The matches will be held in the first available ring a half-hour after the conclusion of judging. Cost of entry is \$10. Match entries will be taken day of show only. Dogs do not need to be permanently registered with UKC or have a Temporary Listing (TL) number in order to compete in the puppy matches.

SPOT Evaluations: SPOT evaluations will be offered at this event. Entry fee is \$10 and will be taken day of show only.

GENERAL INFORMATION

- All events will be held indoors or under cover.
- Please remember to keep all grooming to a minimum per UKC rules.
- Grounds will be open to exhibitors by 7 a.m. on Friday, November 13. Overnight security is not provided, and no dog(s) may be left unattended overnight. The building will be locked at 9:00 p.m. each evening.
- All times are Central Time.
- There will be absolutely NO SMOKING and NO VAPING in all buildings, or around the designated crating areas. No smoking or vaping within 25 feet of entrances.
- No general admission or parking fees will be charged.

FACILITY RULES AND SHOW GUIDELINES

- The building set-up and show committee have complete authority over crating and grooming areas. Crating and grooming will be available on a first-come, first-served basis. There will be absolutely no saving of space by use of tables, chairs, ice chests, ropes, equipment, or any other means for those not present.
- No ex-pens will be allowed in the building.
- **Exhibitors are expected to clean up after their dogs.**
- No dumping of water pans, buckets, or other containers in the sinks in the restrooms.
- The use of duct tape (or any tape that leaves residue) is prohibited for use on walls or floors.

- Each exhibitor is responsible for clean conditions around his/her grooming areas – bring your broom, etc.
- Please dispose of unwanted dog food in trash cans, NOT in commodes in the restrooms.
- NO DUMPING OF HOLDING TANKS, GREY WATER, OR SEWAGE ON SHOW GROUNDS. All vehicles will be parked at owner's risk. The city of Marshall, UDOG, & UKC will not be responsible for loss by fire, burglary, theft, or any other cause whatsoever to any vehicle or its contents.
