**Entry Limits:** Obedience will be limited to 30 entries per day, and Rally Obedience will be limited to 60 entries per day.

**Total Dog/Total Junior:** Offered each day. To qualify, exhibitors need at least one Conformation win and one Performance qualification on the same day to qualify for Total Dog and Total Junior. Wins do not carry over to the next day. Altered dogs may compete in Altered Conformation for an Altered Total Dog Award.

**Total Dog Invitational Qualifying Event!** Any dog that earns a Total Dog at the 2021 Texas Classic will automatically qualify to enter the Total Dog Invitational event to be held in October of 2022 and compete for a grand prize of \$10,000! Entry forms for the Total Dog Invitational will be sent in August 2022.

**SPOT Evaluations:** SPOT evaluations will be offered on Saturday and Sunday. Entry fee is \$10 and will be taken day of show only. Entries will be taken at the Superintendent's table beginning on Friday. Entries will be taken during the SPOT evaluation times - please enter before 1:00pm on Saturday and before 12:00pm on Sunday.

## GENERAL INFORMATION

- All events will be held indoors or under cover.
