Total Dog/Total Junior: Offered each day. To qualify, exhibitors need at least one Conformation win and one Performance qualification on the same day to qualify for Total Dog and Total Junior. Wins do not carry over to the next day. Altered dogs may compete in Altered Conformation for an Altered Total Dog Award.

Total Dog Invitational Qualifying Event! Any dog that earns a Total Dog at the 2020 Virginia Classic will automatically qualify to enter the Total Dog Invitational event to be held in October of 2021 and compete for a grand prize of \$10,000! Entry forms for the Total Dog Invitational will be sent in August 2021.

Non-Licensed Classes: Non-Licensed Veteran and Puppy classes will be offered in Show 1 each day and will show after the licensed classes for their breed. Breed winners will automatically advance to Best Veteran/Puppy in Show competition. Cost of entry is \$10. Dogs do not need to be permanently registered with UKC or have a Temporary Listing (TL) number in order to compete in Novice Puppy.

GENERAL INFORMATION

- This event is indoors.
- Please remember to keep all grooming to a minimum per UKC rules.
- Grounds will be open to exhibitors by 7 a.m. on Friday, December 4. Overnight security is not provided, and no dog(s) may be left unattended overnight.
- All times are Eastern Standard Time.
- There will be absolutely NO SMOKING and NO VAPING in all buildings, on the show lawn, or around the designated crating areas. No smoking or vaping within 25 feet of any shade canopies.
- No general admission or parking fees will be charged.

INDOOR CRATING

Indoor crating will be available. In an effort to limit the number of people in the building, we ask that you do not come into the building until 30 minutes before your start time, located in the Judging Program. Masks will be required at all times when in the building. Those working out of their vehicles will need a mask upon entering the building.

Pre-Entries must be submitted via UKC's online entry system, mail, or fax. Pre-entries will be opened on Monday, October 19, 2020 at 8:00 a.m. Eastern time. All pre-entries must be received by UKC by Friday, November 20, 2020, 11:59pm Eastern time. No pre-entries will be accepted or processed after that time.
