Total Dog/Total Junior: Offered each day. To qualify, exhibitors need at least one Conformation win and one Performance qualification on the same day to qualify for Total Dog and Total Junior. Wins do not carry over to the next day. Altered dogs may compete in Altered Conformation for an Altered Total Dog Award.

Total Dog Invitational Qualifying Event! Any dog that earns a Total Dog at the 2020 Washington Classic will automatically qualify to enter the Total Dog Invitational event to be held in October of 2021 and compete for a grand prize of \$10,000! Entry forms for the Total Dog Invitational will be sent in August 2021.

Non-Licensed Classes: The Novice Puppy and Veteran classes will not be offered in 2020

GENERAL INFORMATION

- This event is outdoors. Conformation will be held outdoors on grass. All performance events are held in the covered arena.
- Please remember to keep all grooming to a minimum per UKC rules.
- Grounds will be open to exhibitors by 7 a.m. on Friday, September 18. Overnight security is not provided, and no dog(s) may be left unattended overnight.
- All times are Pacific Time.
- There will be absolutely NO SMOKING and NO VAPING in all buildings, on the show lawn, or around the designated crating areas. No smoking or vaping within 25 feet of any shade canopies.
- No general admission or parking fees will be charged.

ROUTES TO THE SHOW

Argus Ranch Facility for Dogs, 35612 212th Way SE, Auburn WA 98092 253.333.2347

From North or South End: Take I-5, I-405, SR-167 to Highway 18 eastbound. Take Auburn-Black Diamond Rd eastbound exit. Turn Right onto Auburn Black Diamond Rd. Turn RIGHT onto SE Green Valley Rd (just past Neely Mansion). Follow for about 7.5 miles. Turn RIGHT onto 212th Way SE. Go over bridge take First LEFT into Argus Ranch and follow drive straight ahead to Arena and parking.

From Hwy. 410 or WA 164 (Auburn-Enumclaw Hwy.): Turn LEFT onto 244th Ave SE (approximately one mile out of Buckley). Go STRAIGHT at Light on SE 436th Way/WA-164. Go STRAIGHT at Stop Sign SE 416th St. Go STRAIGHT at Stop Sign SE 400th St. Turn LEFT at Stop Sign onto SE 384th St. Turn RIGHT at Stop Sign 212th WAY SE. Turn RIGHT at ARGUS RANCH Sign (just before Bridge). Follow drive STRAIGHT ahead to Arena and signed parking.

From SR 169 Southbound: Right onto Roberts Dr (in front of the Coal Car), go approximately four miles. Left onto 218th St. At bottom of the hill is a stop sign. Go straight across over cement bridge (Whitney Bridge). Take First Left into Argus Ranch and follow drive straight ahead to Arena and signed parking.

From SR-169 Northbound. Turn LEFT onto SE Green Valley Rd (in front of the Boondocks Nursery). Go about four miles. Turn LEFT onto 212th Way SE. Go over the Cement Bridge. (Whitney Bridge). Take First LEFT into ARGUS RANCH and follow drive straight ahead to Arena and signed parking.
