CRATING AND GROOMING:

Exhibitors may bring personal canopies for crating and grooming on the event lawn.

Entry Limits: Entries will not be accepted past an 8-hour judging time. Obedience will be limited to 30 entries per day, and Rally Obedience will be limited to 60 entries per day. Precision Coursing will be limited to 125 entries per day.

Total Dog/Total Junior: Offered each day. To qualify, exhibitors need at least one Conformation win and one Performance qualification on the same day to qualify for Total Dog and Total Junior. Wins do not carry over to the next day. Altered dogs may compete in Altered Conformation for an Altered Total Dog Award.

Total Dog Invitational Qualifying Event! Any dog that earns a Total Dog at the 2025 Western Classic will automatically qualify to enter the Total Dog Invitational event to be held in November 2025 and compete for a grand prize of \$10,000! Entry forms for the Total Dog Invitational will be sent in October of 2025.

Non-Licensed Classes: Non-Licensed Veteran and Puppy classes will be offered and will show after the licensed classes for their breed. Breed winners will automatically advance to Best Veteran/Puppy in Show competition. Cost of entry is \$15. Day of show entries will be available. The Veteran class will be offered on Friday, Show 1 and the Novice Puppy class will be offered on Saturday, Show 1. Dogs do not need to be permanently registered with UKC or have a Temporary Listing (TL) number to compete in Novice Puppy.

GENERAL INFORMATION:

- This event is outdoors.
- Please remember to keep all grooming to a minimum according to the UKC rules.
- Grounds will be open to exhibitors by 7 a.m. on Friday, August 1. Overnight security is not provided, and no dog(s) may be left unattended overnight.
- All times are Pacific Time.
- There will be absolutely NO SMOKING and NO VAPING in all buildings, on the show lawn, or around the designated crating areas. No smoking or vaping within 25 feet of any shade canopies.
- No general admission or parking fees will be charged.

ENTRY FEES

Pre-Entry

Pre-Entries must be submitted via UKC's online entry system. Pre-entries will be opened on Monday, June 2, 2025, at 8:00 a.m. Eastern time. All pre-entries must be received by UKC by Monday, July 7, 2025, 11:59 p.m. Eastern time. No pre-entries will be accepted or processed after that time.

Pre-Entry Specials

Each entry submitted after the 6th entry for the same dog will be charged \$15, regardless of event type entered. To receive the discounted price, all entries must be submitted at the same time on one online entry form. Entries made for the same dog at different times will not be eligible for the discounted rate.

Entry Cancellation and Refunds

Entry cancellations must be received in writing prior to the close of entries. Request must include dog's UKC number, breed, name, and event type entered. Cancellations by phone or chat will not be accepted. Emailed cancellations must be sent to:

Cancelled entries submitted before the close of entries will be charged a cancellation fee. The cancellation fee is \$3 per entered class. No entries will be refunded after the closing date and time or after entry limits have been reached, except in the case of females that come into season and are entered in a performance event. For females in season, a veterinarian's official statement that the female is in season must accompany the cancellation request.

If, because of riots, civil disturbances, or other acts beyond the control of the host organization, it is impossible to open or to complete an event, no refund of entry fees will be made.
