TOTAL DOG INVITATIONAL QUALIFYING EVENT

Any dog that earns a Total Dog at the 2025 Western Classic will automatically qualify to enter the Total Dog Invitational event to be held in November of 2025 and compete for a grand prize of \$10,000! Entry forms for the Total Dog Invitational will be sent in Fall of 2025.

TOTAL DOG/TOTAL DOG JUNIOR

Offered each day. To qualify, exhibitors need at least one Conformation win and one Performance qualification on the same day to qualify for Total Dog and Total Junior. Wins do not carry over to the next day. Altered dogs may compete in Altered Conformation for an Altered Total Dog Award. Conformation wins include any of the following wins over competition: Best Male/Female, Best of Winners, Champion, Reserve Champion, Grand Champion, Reserve Grand Champion, Group 1–4, Best in Show, Reserve Best in Show.

Saturday Show 1: Novice Puppy and Veteran breed winners will advance directly to their respective Best in Show class. Best In Show order will be Novice Puppy, Veteran, Altered then regular Best In Show.
