The winner of each class division shall be the dog scoring the highest score of all dogs in the class division. The dog scoring the next highest score shall be placed second and so forth. Each successive dog is placed second, third, then fourth. If two or more dogs earn the same score, the winner shall be the dog with the greatest difference between its running time and the Assigned Course Time (ACT minus running time.) If the two dogs remain tied, the tie shall stand. This same procedure is used to determine the High in Trial award.
